The activities carried during the year 2020-2021 are as below:-

❖ **MOBILE FREE MEDICAL CAMPS** :The Trust has been organized general Health check-up & Eye screening camps at various places of Paschim Medinipur. Trained & qualified Doctors & Staff are screening the patients. In 2020-2021 season the Trust has managed 2 numbers of general health & Eye screening camp where 271 numbers of patients were screened. provided free medicine and consultation there as much as possible from our end. The Trust has spent a sum of Rs. 12640.00 for this purpose during the year.

❖ **PLANTATION & ENVIRONMENT AWARENESS CAMPS**: To avoid natural calamities and environment pollution the Society executed some programmes to build up the Environment awareness. Environment Awareness Camps were held on 5th June as World Environment day through Tree Distribution among students & Local People, our volunteers were given the awareness how to protect environment. 620 Nos. various wooden tree, Flower & Various Medical Plants distribute various type of local people & Student for Plantation. The Society has spent a sum of Rs. 8320.00 for this purpose during the year.

❖ **BLANKET / CLOTH DISTRIBUTION PROGRAMME** :Our Society Has distribute the clothes/Blankets to the weaker people and old age women person who are not supported by their sons & daughter and family members, they need a hand for being supported our Trust is donated to the needy peoples for their help in the old age . The donated programs were managed under the direction of our Chairman. The Trust has spent Rs. 6340.00 for this purpose during the year.
